

As part of the Millennium Villages Initiative, KPMG committed \$1.5m to support the development of Kiuyu Mbuyuni village in Pemba.

- Constructed a new maternity block in the community health center
- Delivered an immunization and malaria prevention program
- Provided information on family planning and reproductive health
- Rehabilitated the road that connects seaweed farms, beach landing stations and the community center

- Completed a teacher training needs assessment and trained teachers
- Revived the health committee and recruited and trained 10 community health workers
- Brought electricity to an additional 400 households
- Trained 80 farmers on conservation farming techniques
- Planted 33,422 trees to help retain topsoil and become a sustainable resource
- Constructed four new classrooms, including an IT classroom
